**Subject: Immediate Disbursement of Salary for the month of March-2021 on account of good collection-Reg.**

This is to apprise that delay in disbursement of salary on last working day is persisting since more than a year and the employees are at receiving end due to the delay. The ongoing month is the last month of the financial year 2020-21 and it has a trend of the highest earning month and the collection is expected to be double of the normal days. It has come to our information that DoT is also clearing certain pending payment to the BSNL as well as the management has secured loan to clear outstanding amounts of various vendors and departments for their supplies/services rendered under CAPEX and OPEX.

As the cash flow in the month has increased and loan is also getting secured by BSNL for clearing liabilities, the employee's Salary should also be treated in the top most priorities of the management. It is important to note here that the total Take Home Salary, which is just about Rs 400 Cr, is getting delayed by about 20-22 days every month and frequency remains almost constant. If the management could advance it to the scheduled date i.e. Last Working Date of the month, the momentum can be continued and employees will be able to get the Salary on due date always.

Further, it is the prime responsibility of the management to ensure wages/salary on the last day of the month and in the present circumstances, the current month can be the best time to attain it. Non-payment of salary on time has resulted into erosion of social status of the
