**Subject**: Dissolution of existing AIGETOA Chennai CEC body, formation of an interim committee and delegation of charge of the works of the Circle Secretary to Shri Senthil Kumar K (Auditor AIGETOA CHQ).

The Circle Management is requested to extend cooperation, recognition and due facilities to Shri Senthil Kumar K in discharging his duties and responsibilities of the works associated with a Circle Secretary in the larger interest of the members and executives of Chennai TD.

We assure one and all that the interim team and Sri Senthil Kumar K will work fairly in the period and fulfil their assigned duties and responsibilities effectively and ensure placement of new Circle Body of AIGETOA Chennai Chapter within Three Months.
